OFFICIAL RULES – For On-Site Promotion 8/24/2024

1. How to Participate:

WBNX-TV55 Event Crew will be on-site at the Portage County Randolph Fair 2024 event located at The Portage County Randolph Fairgrounds, 4215 Fairground Rd. Atwater, OH 44201 on Saturday, August 24, 2024, from 12:00pm-7:00PM at a table set-up outside the fair office.

PRIZE DRAWING, HOW TO ENTER:
